The U.S. Department of Agriculture (USDA) invites offers to sell shrimp products pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due on January 29, 2024. Acceptances will be announced by 11:59 pm CT on January 31, 2024.

Deliveries are to be made between March 16, 2024 through June 30, 2024.
