The U.S. Department of Agriculture (USDA) invites offers to sell Salmon, and Walleye pursuant to the AMS Master Solicitation for use in the domestic food distribution programs. Bids are due on May 9, 2024. Acceptances will be announced by 11:59 pm CT on May 16, 2024.

For the purposes of this rule, successful delivery is defined as product delivered on-time and in acceptable condition according to the terms and conditions of the contract. Any delivery problems directly attributable to the Government will not be held against the contractor.


